## Agenda

#### Summary of the discussions





- 1. The agenda of the meeting is approved.
- 2. The minutes of the previous meeting are approved. Action 1 & 2 are closed. In relation to Action 1, it is noted that the mirroring of IO sources in EU remains to addressed through the federated access schemed being deployed in EU and on the basis of the framework license agreement between IO and the European Commission. A meeting involving Simon, Marcin (PSNC), Pär and Olivier should take place to discuss technical aspects.
- 3. Gloria Falchetto (GF) mentions the work on the IMASification of the data bases and refers to a presentation by Xavier Litaudon at a meeting of the EUROfusion Fusion Science Department.

AL enquires about the backward compatibility that remains an issue. It is agreed to organize a meeting involving the coordinators of the various databases, Simon, Olivier and Alberto to discuss (i) the progress on the IMASification, (ii) the issue of backward compatibility and (iii) new definitions

- 4. In the context of the support to the Administrative Arrangement, it appears useful that IO puts forward a formal request to the Commission for accessing sources they should be allowed to access by virtue of the license agreement as well sources they wish to access. To this end, IO (Simon) should establish a list of items that IO cannot access and of items they additionally wish to access
